

## **ADP Canada National Employment Report: Employment in Canada Decreased by 226,700 Jobs in April 2020**

**TORONTO, ON – May 21, 2020** – Employment in Canada decreased by 226,700 jobs from March to April according to the April ADP® *Canada National Employment Report*. Broadly distributed to the public each month, free of charge, the *ADP Canada National Employment Report* is produced by the ADP Research Institute®. The report, which is derived from actual ADP payroll data, measures the change in total nonfarm payroll employment each month on a seasonally-adjusted basis.

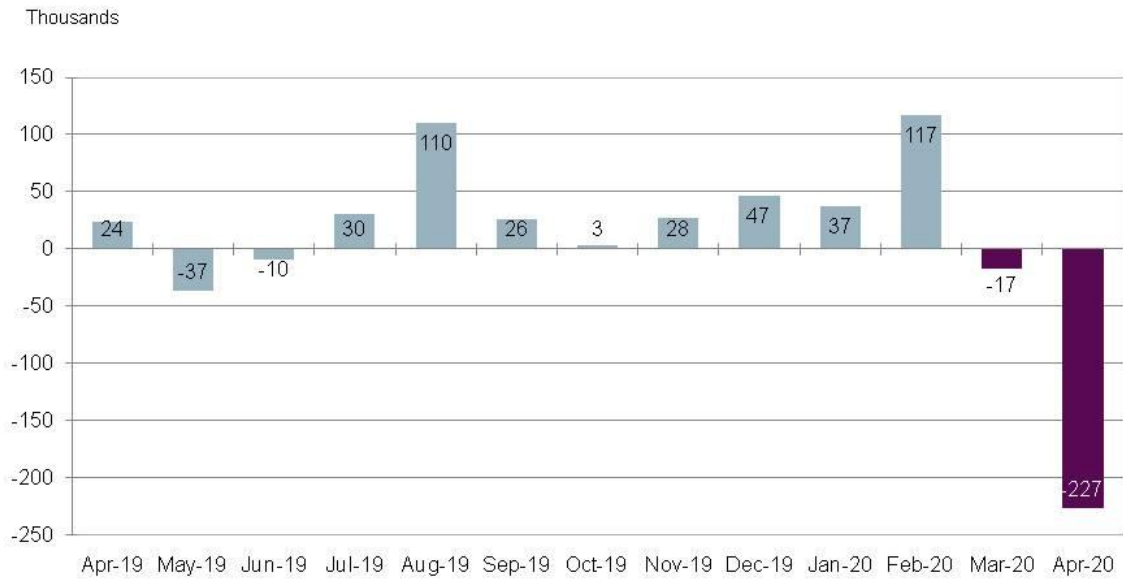

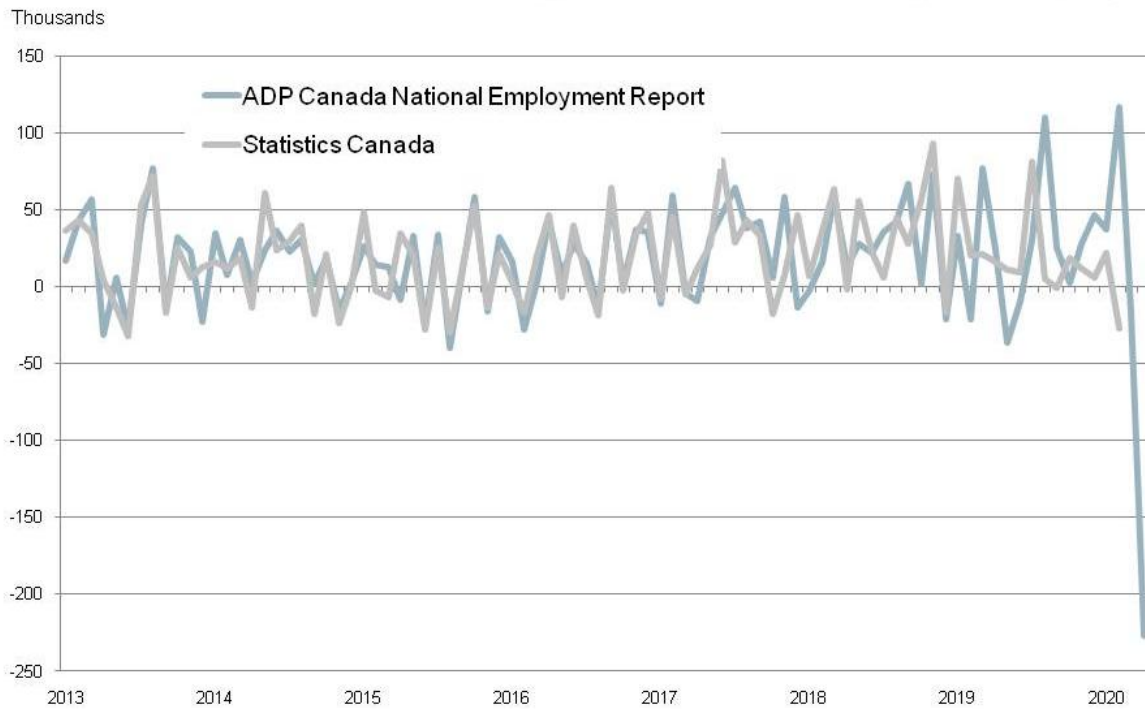

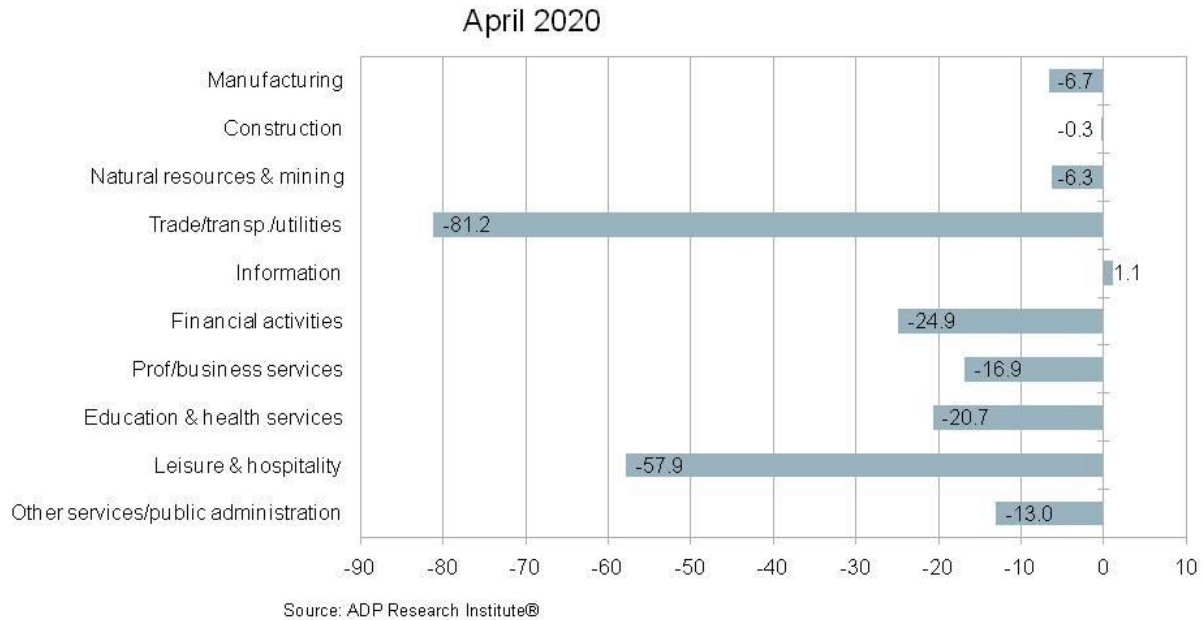
### Chart 1. Change in Total Nonfarm Payroll Employment
